Tampakan	Philippines	Project cancelled until further notice after two decades of community opposition. ⁷
Bougainville	Papua New Guinea	Rio Tinto mine forced to shut down in 1989 due to local tensions regarding revenues and environmental damage. ⁸
Porgera	Papua New Guinea	Social problems and environmental concerns led government not to extend mining license in April 2020.
